Enter the Latino Center for Wellness and Education (LCWE) Logo Design Contest.

Contest Prize: The winner will have his/her name and contact information on the LCWE website for six months.

Contest Goal: To create a logo that reflects the mission statement of LCWE: The LCWE promotes health awareness, education, integration, and resource information to improve the quality of life in the Latino community. Our design will be used on the web, print media, mugs & t-shirts.

Submission: All entries must be sent to latinocenter_tippecanoe@live.com by September 1, 2010 in the form of JPEG. All intellectual property and industrial property rights in any entries that belonged to the entrants will remain with the entrants, but the submissions will otherwise become the property of LCWE, and will not be returned after the contest. Each entrant agrees not to participate in the Contest in any manner that might (1) infringe any third-party proprietary, intellectual property, industrial property, personal rights or other rights, including without limitation, copyright, trademark, patent, trade secret or confidentiality obligation; or (2) otherwise violate applicable law in any countries in the world. The submission must not disparage any person or entity. The submission must not contain material that is inappropriate, indecent, obscene, hateful, tortuous and/or defamatory; the submission must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age.

Rules:

- Voting will be cast by the LCWE board. The winner will be announced December 2010. The contest does not carry a cash prize.
- Font, color and style is open and subject to change by final decision of the LCWE board.
- No purchase necessary.
- All rights of chosen logo are reserved to the LCWE.
- The LCWE and its affiliates, agents, and employees, and the sponsor and its affiliates, agents, and employees are not responsible for any damage to computer systems from downloading any information necessary to participate in the Contest.
- The LCWE reserves the right to terminate or modify the Contest at any time.
- All expenses incurred in creating the Contest entry (i.e. software purchases, images) are the responsibility of the contestant.
- This contest is governed by any and all applicable federal, state, and local laws and regulations. Void where prohibited.
- **Binding Agreement:** In order to enter the contest, you must agree to these official rules ("Rules"). Because you will be bound by these Rules and these
